**I understand and agree to the following:**

1. There is an initial, non-refundable enrollment fee of \$50 per child due with this contract. If I withdraw my child/ren, I understand that there will be a re-enrollment fee.
2. I understand there will be an annual supply fee of \$25 (\$40 for two or more children) charged on the first invoice.
3. Weekly tuition is due in advance per the above checked schedule.
4. A late fee will be added to my bill if weekly payment is not received by Friday at 5:30pm.
5. If my bill is more than one week past due my child/ren will not be able to attend until tuition and late charges are paid.
6. I will pay the agreed upon tuition whether my child/ren is/are present or not. This includes family vacations, medical leave, illness, school cancellations, etc.
7. I understand I will receive one free week per year. This is to be taken a full week at a time and my child/ren **will not attend during that week.**
8. A late charge of \$1.00 per minute per child will be charged for pick up **after closing time.**
9. I will be responsible for any and all fees, charges, or expenses that Little Saints would have to pay in order to collect any bad debt.
10. I must give at least two weeks' notice prior to withdrawing my child/ren.
11. If I am receiving CCDF (Vouchers), I understand that I am responsible to pay the amount that is not covered by CCDF. In the event that I do not bring my child the hours required by CCDF or if I lose CCDF I am responsible for the entire amount due.

**Half-Day Pre-K 4's/5's Class - Mondays, Wednesdays, and Fridays 8:30-12:30pm**

\_\_\_\_\_ **Nine Equal Payments** of \$145 Payments due at the beginning of each month August 6, 2021 through May 2, 2022.

**I understand and agree to the following:**

1. There is an initial, non-refundable \$50 enrollment fee due to guarantee a spot for my child in preschool. If I should withdraw my child, I understand that there will be a re-enrollment fee.
2. If I should withdraw my child and re-enroll the child within two weeks, I will pay back charges for the time the child was not enrolled.
3. I understand there will a supply fee of \$25 charged on the first invoice.
4. Tuition is due per the above checked schedule.
5. A late fee will be added to my bill beginning the first day my payment is past due.
6. If my bill is more than one week past due my child will not be able to attend until tuition and late charges have been paid.
7. I will pay the agreed upon tuition whether my child is present or not. This includes family vacations, medical leave, illness, school cancellations, etc.
8. A late charge of \$1.00 per minute for three year olds picked up after 10:45 am and for Pre-K children picked up after 12:45 pm will be charged.
9. I will be responsible for any and all fees, charges, or expenses that Little Saints Child Care and Preschool Ministry would have to pay in order to collect any bad debt.
10. I will give at least two weeks' notice prior to withdrawing my child.

## Half-Day Preschool Tuition Rates for 2021/2022 School Year

Registration Fee - \$50

Annual Supply Fee - \$25

Registration Fee is required at time of registration to secure spot in Half-Day Preschool. A spot is not guaranteed until the registration fee is paid. Annual Supply Fee will be charged on the first preschool tuition invoice.

**Half-Day Preschool Class** – Meets Tuesdays and Thursdays from 8:30am – 10:30 am  
\$88 per month, August through May

**Half-Day Pre-K Class**– Meets Mondays, Wednesdays, and Fridays from 8:30am – 12:30 pm  
\$145 per month, August through May

**Full Day Preschool or Pre-K-** Must fill out full time weekly tuition contract

Tuition payments for the half-day program may be made annually, quarterly, or monthly. Annual payments are due before preschool starts; quarterly and monthly payments are due before the first day of the quarter or month the payment is for. There is a 10% discount for those paying annually and a 5% discount for those paying quarterly.

Please fill out the enclosed tuition contract, check the payment plan you are going to use, sign and date it and give to the Child Care Director or Preschool teacher. When paying monthly, remember that there will be nine equal monthly payments regardless of the number of days children attend school during that month. If you are choosing one annual payment that payment is due no later than August 6, 2021.

**Classes will begin** August 11, 2021 for the Half-Day 4/5's Pre-K and August 12, 2021 for the Half-Day 3/4's Preschool Class. Classes will end the week of May 23-27, 2021, respectively. The make-up day schedule will be determined and parents will be notified as soon as possible. Preschool Graduation will occur during the last week of May. Please see the Preschool Parent Handbook for additional information.

**Ministry Waiver**

I understand that this day care ministry is not licensed under the laws of Indiana. However, I understand that this day care ministry complies with the State rules concerning sanitation & fire safety for the primary use of the structure in which it is conducted. I understand that it is my responsibility to ensure that the nutritional and health needs of my child are met while my child is at the day care ministry. This notice does not absolve a day care ministry from liability for injury to a child while the child is at the day care ministry if the cause of the injury is negligence or intentional wrongdoing on the part of the day care ministry or an employee of the day care ministry. This waiver is updated annually.

**Notice Concerning Fire Safety Protection**

Under Indiana Law, a child care ministry may choose not to provide certain fire safety protections if the parent(s) or legal guardian(s) of each child is notified about the absence of the fire protection safety protections. The purpose of this notice is to advise you that this child care ministry does not have the same level of fire safety protection as a licensed center. As you have already been notified, the child care ministry does not comply with the same sanitation, life and fire safety rules as a licensed center. The reason you are given this notice is that the child care ministry has chosen not to provide a fire warning system, such as fire alarms, as is required for a licensed day care center. However, we do use active smoke detectors, have fire extinguishers if needed, and conduct monthly fire drills (as of March 2005).

**Discipline/Guidance Policy**

It is very important that a child's development is nurtured through caring, patience and understanding. However, while caring for your children, I may have to respond to your child's misbehavior. Hitting, kicking, spitting, hostile verbal and other behaviors which will hurt other children are not permitted.

**In response to these behaviors, I will NOT use the following:**

- Threats or bribes
- Physical punishment, even if requested by the parent
- Deprive your child of food or other basic needs
- Humiliation or isolation

**In response to misbehavior, I WILL use the following:**

- Respect for the child
- Establish clear rules
- Be consistent in enforcing rules
- Use positive language to explain desired behavior
- Speak calmly while bending down to your child's eye level
- Give clear choices
- Redirect your child to a safe area for a "time out" no longer than one minute per year of the child's age. If your child's behavior is very disruptive or harmful to himself or other children, I will discuss the issue with you privately. If the situation can be resolved, the child may remain enrolled in the program. If we are unable to resolve the issue, you may be asked to make other child care arrangements.
